

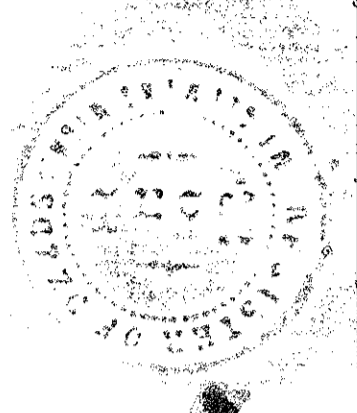

Warren Township, Macomb County, Mich. is described as follows: Beginning at the Center of Section 22 T. 1 N. R. 12 E. thence along Nly line of S.E. 1/4 of Sec. 22, S 89° 33' E, 1329.04 feet to a point in the center line of Gilbert Ave.; thence along center line of said Ave. S 0° 52' 30" W, 656.4 feet to a point; thence N 89° 56' 20" W, 1324.57 feet to a point in the center line of Herbert Ave., also being the Wly line of S.E. 1/4 of Sec. 22; thence along said line S 0° 29' W, 325.75 feet to a point; thence N 89° 57' W, 3035.83 feet to a point in the center line of Van Dyke Ave., also being the Wly line of Sec. 22; thence along said line North 278.80 feet to a point; thence East 150.00 feet to a point; thence North, 50.00 feet to a point; thence East 132.21 feet to a point; thence N 1° E, 248.85 feet to a point; thence S 89° 53' E, 2754.07 feet to a point in the center line of Herbert Ave. also being the Wly line of S.E. 1/4 of Sec. 22; thence along said line N 0° 29' E, 416.3 feet to place of Beginning.
